What is this product?

Type

The fund is a UCITS fund established in Germany. The fund's depositary is BNP PARIBAS S.A., German branch.

Term

The fund is of unlimited duration. The Company is entitled to terminate the management of the Fund by giving six months' notice in the Federal Gazette (Bundesanzeiger) and in the annual or semi-annual report. Please refer to the section 'How long should I hold it and can I take money out early?' for information on the possibility of redemption and the frequency of redemptions.

Objectives

The medium-term objective of the fund is to achieve a steady positive return and attractive capital growth, taking into account environmental and social criteria.

To achieve this, the fund invests primarily in bonds issued by issuers domiciled in Europe. Equities of large international companies may be added to the Fund's assets, normally in proportions of between 10 and 25 per cent (permissible between 0 and 49 per cent). Environmental and social criteria are taken into account when selecting suitable investments. Particular attention is paid to risk management in order to minimise fluctuations in unit prices and achieve greater stability in the fund. Within this framework, the selection of individual securities is the responsibility of the fund management. Benchmark: 20% IBOXX EURO CORP. ALL MATS - TR, 25% IBOXX EURO SOVEREIGN 1-10, 25% IBOXX Euro Covered 1-10, 20% MSCI World Selection Net Return EUR Index, 10% JPM EU EMBI GLB DIVS COMPOSITE - TR. The fund is actively managed, i.e. the fund manager makes discretionary asset selection decisions and may invest in securities not included in the benchmark index in order to take advantage of investment opportunities. As a result, the composition of the Fund and its performance may differ significantly from that of its performance indicator, either positively or negatively, over the long term.

The fund may use derivatives to reduce possible losses due to interest rate and currency fluctuations, to achieve higher capital growth and to profit from rising or falling prices. Derivatives are financial instruments whose value depends on the performance of one or more underlying assets, e.g. a security, index or interest rate.

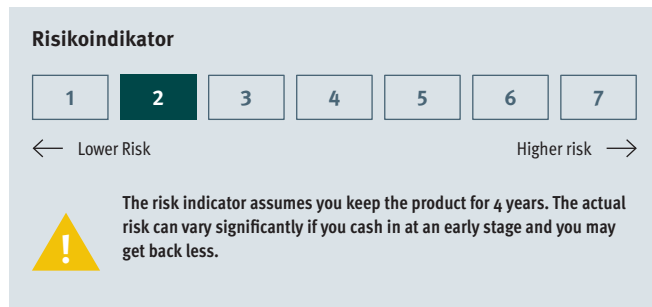
The fund's income is usually distributed. In addition, bank deposits may be distributed (so-called capital distribution), which may reduce the value of the fund.

The fund's return depends on the performance of the fund, which is directly related to the performance of its investments.

Intended retail investor

The fund is aimed at all investors who pursue the goal of capital accumulation or asset optimisation and have a medium-term investment horizon. This fund is a product for customers with basic knowledge and/or experience of financial products. The potential investor could bear a financial loss and does not attach any importance to capital protection. The fund promotes environmental and/or social characteristics and is also suitable for investors with these specific requirements.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. The risk of potential losses from future performance is classified as 2 = „low“. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the fund to pay you.

The following risks may be material to the fund and are not adequately captured by the risk indicator:

There may be risks of loss resulting from insolvency, breaches of due diligence or abusive conduct on the part of the (sub-)custodian or operational risks.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

What happens if the company is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have made the following assumptions:

- In the first year you would get back the amount that you invested (0% annual return).
- For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- EUR 10 000 is invested.

* This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 1,4 % before costs and -0,4 % after costs.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years

The recommended holding period is the period of time that, based on experience, an investor should hold shares in the fund in order to achieve an attractive level of capital growth, taking into account costs. The Company will not charge you any costs or fees on exit. Investors may, in principle, request the redemption of units from the Company or the Custodian on any Valuation Day. The Company may suspend the redemption of units if exceptional circumstances make this appear necessary, taking into account the interests of the investors, or limit the redemption of units if the redemption requests of the investors reach a predetermined threshold, above which the redemption requests can no longer be executed in the interests of the investors as a whole.
