What is this product?

Type

The fund is a UCITS fund established in Germany. The fund's depositary is BNP PARIBAS S.A., German branch.

Term

The fund is of unlimited duration. The Company is entitled to terminate the management of the Fund by giving six months' notice in the Federal Gazette (Bundesanzeiger) and in the annual or semi-annual report. Please refer to the section 'How long should I hold it and can I take money out early?' for information on the possibility of redemption and the frequency of redemptions.

Objectives

The objective of the fund is to achieve attractive growth while taking account of environmental and social criteria.

To achieve this, the fund invests worldwide in large leading companies that contribute to responsible economic growth. The selection of suitable investments takes into account ecological and social criteria. In this context, the selection of the individual securities is the responsibility of the fund management. Benchmark: MSCI World Selection Net Return EUR Index. The fund is actively managed, i.e. the fund management decides at its own discretion on the selection of assets and can invest in securities that are not included in the benchmark index in order to take advantage of investment opportunities. The composition of the fund and its performance may therefore differ significantly or completely and in the long term – positively or negatively – from the benchmark index.

The fund may use derivatives to reduce possible losses due to interest rate and currency fluctuations, to achieve higher capital growth and to benefit from rising or falling prices. Derivatives are financial instruments whose value depends on the performance of one or more underlying assets, such as a security, index or interest rate.

The fund's income is usually distributed. In addition, bank deposits may be distributed (so-called capital distribution), which may reduce the value of the fund

The fund's return depends on the performance of the fund, which is directly related to the performance of its investments.

Intended retail investor

The Fund is aimed at all investors who have a long-term investment horizon and are seeking to accumulate or optimise their assets. This fund is a product for customers with basic knowledge and/or experience of financial products. The potential investor could bear a financial loss and does not attach any importance to capital protection. The fund promotes environmental and/or social characteristics and is also suitable for investors with these specific requirements.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium-low risk class. The risk of potential losses from future performance is classified as 4 = "medium". This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the fund to pay you.

The following risks may be material to the fund and are not adequately captured by the risk indicator:

There may be risks of loss resulting from insolvency, breaches of due diligence or abusive conduct on the part of the (sub-)custodian or operational risks.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 13 years. Markets could develop very differently in the future.

What happens if the company is unable to pay out?

- For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 8 years

The recommended holding period is the period of time that, based on experience, an investor should hold shares in the fund in order to achieve an attractive level of capital growth, taking into account costs. The Company will not charge you any costs or fees on exit. Investors may, in principle, request the redemption of units from the Company or the Custodian on any Valuation Day. The Company may suspend the redemption of units if exceptional circumstances make this appear necessary, taking into account the interests of the investors, or limit the redemption of units if the redemption requests of the investors reach a predetermined threshold, above which the redemption requests can no longer be executed in the interests of the investors as a whole.
